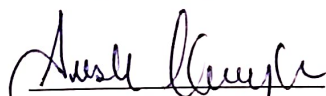

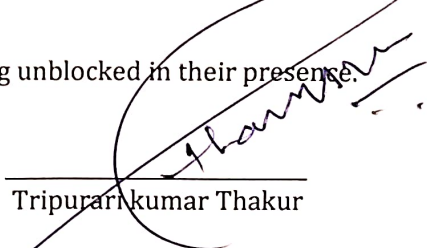

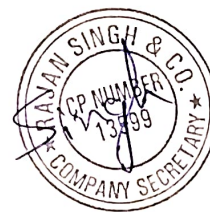
1. The E-Voting period remained open from Monday 22nd September 2025, at 09:00 A.M. and ends on

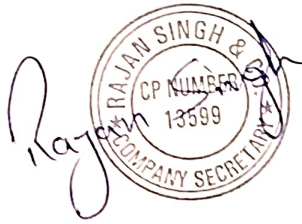
